## Location

Situated in one of the best areas of Torremolinos, the property is located in a tranquil and established setting, directly opposite the Sunny View school and next to the protected natural area of Pinar del Moro. Its privileged location offers immediate access to a wide variety of services, such as public schools and institutes, Municipal Sports Board facilities, the Municipal Auditorium, the Los Manantiales recreational area, and supermarkets. Furthermore, it boasts unbeatable connections to the province's main road networks, facilitating access to Málaga city, the airport, and other towns on the Costa del Sol.

## Layout

The penthouse has a built area of 183m<sup>2</sup>, 89 m<sup>2</sup> of usable space, and a 56 m<sup>2</sup> terrace. It is distributed into an entrance hall with built-in wardrobes, a spacious and bright living-dining room with access to the open terrace adjacent to the property, ideal for outdoor dining and a chill-out area. There is an open-plan American kitchen, fully furnished with upper and lower cabinets, a laundry area, and three bedrooms with built-in wardrobes. The master bedroom features a dressing room and an en-suite bathroom; there is a second full bathroom serving the rest of the rooms. A second covered terrace is available to be fitted out according to the owners' needs.

## Qualities

The property has been designed with first-class materials and cutting-edge technology to guarantee maximum comfort and energy efficiency. It holds the BREEAM sustainable construction certificate. Highlights include a security entrance door, porcelain floors indoors and non-slip floors on the terrace, aerothermal systems for hot water and ducted air conditioning. The kitchen is equipped with Bosch appliances: compact quartz countertop, induction hob, extractor hood, paneled refrigerator, washing machine, and microwave. Designer bathrooms feature Hansgrohe faucets and vanity units with drawers. There is the possibility to choose the color of the kitchen and flooring according to the buyer's preferences.

## Communal Areas

The residence offers spectacular communal areas designed for the leisure and well-being of the entire family. Highlights include two swimming pools for adults with a solarium and garden area, a children's pool, a fully equipped gym, a multi-purpose room for activities, and a children's play area. The property includes a parking space equipped with an electric car charger and a storage room, both included in the price.
