## Location

Located in one of the most peaceful and well-connected areas of Alhaurín de la Torre, the property is part of an exclusive complex of 16 homes. The location is unbeatable, just 1 km from the A7, which allows quick access to Malaga city, the airport and the main towns of the Costa del Sol. Only 3 km from the centre of Alhaurín de la Torre and 5 km from Churriana, in the surrounding area you will find an excellent range of services nearby, such as supermarkets, schools, sports centres, restaurants and green areas ideal for leisure and family life.

## Distribution

The terraced house faces east and west and sits on a plot of 250m<sup>2</sup> with a total constructed area of 215m<sup>2</sup> and 192m<sup>2</sup> usable area. It is distributed over three floors:

### Ground floor

It consists of 65m<sup>2</sup> and is distributed in an entrance hall, a spacious and bright living-dining room, an open-plan kitchen open to the living room fully furnished with high and low furniture and equipped with electrical appliances, an exit to the open porch with chill-out area and space for an outdoor dining room, a terrace of 49m<sup>2</sup>, and the swimming pool. A small living room with access to the back garden and a guest toilet. A staircase leads to the upper floor.

### First floor

It consists of 59m<sup>2</sup> is distributed in a hallway and has three bedrooms in total. The master bedroom has a large dressing room and an en-suite bathroom, two bedrooms all with fitted wardrobes, and a second bathroom that serves the rest of the bedrooms.

### Basement floor

The basement floor consists of 68m<sup>2</sup> useful and is delivered plastered. It is ideal for storage or a multipurpose room perfect for conditioning according to the needs of its owners.

## Qualities

The property has the best qualities, among which we highlight aerotermia for hot water, pre-installation for air conditioning system using ducts in the living room and bedrooms, large format porcelain stoneware floor on the ground floor, wooden floor on the first floor, porcelain stoneware floor on the terraces, kitchen equipped with monochrome taps, sink, microwave, induction hob, extractor hood, dishwasher and compact quartz worktop, video intercom, LED lighting in the façade of the porch and upper floor terrace, pre-installation of electric motor to operate the entrance to the car park.

## Exterior areas

The terraced house has a 25m<sup>2</sup> garden and a 12m<sup>2</sup> swimming pool. The property has two parking spaces.
